



## **2024 Clean Heat Incentive Updates**

Con Edison announced two sets of incentive changes effective December 5, 2023

- Updated base incentive rates for certain Residential ASHP projects
- Increased incentives under a limited-time 2024 Promotion for specified projects in:
  - Residential ASHP
  - Residential GSHP
  - Multifamily
  - Small-to-medium (SMB) business sectors

## **Residential Sector Incentive Changes**

Three modifications to residential ASHP incentives

- 1. Increased base incentive rates in Category 2b for single dwelling units in buildings with multiple dwelling units;
- 2. Introduced enhanced incentive rates for customers located within Disadvantaged Communities ("DAC");
- 3. Extended the current Limited-Time Fall Promotion as part of the 2024 Promotion Rates.

## Residential Decommissioning (Cat. 2b) Rates in 2024

- Increased base incentive rates for single dwelling units in multiple dwelling unit buildings
- Introduced DAC rates for projects submitted through 2024
- Extended and enhanced the 2023 Limited-Time Fall Promotion as part of the 2024 Promotion
  - Project applications must be submitted by May 31, 2024, and installed on or after December 5, 2023

- Integrated controls projects are not included in the 2024 Promotion

#### **Residential GSHP: 2024 Promotion**

To be eligible for the 2024 Promotion, GSHP projects must:

- Be installed between December 5, 2023, through December 31, 2024
- Submit signed customer commitments by May 31, 2024

## **Multifamily: Increased Incentives in 2024 Promotion**

To be eligible for 2024 Promotion, MF projects must:

- Submit applications between December 5, 2023, through May 31, 2024
- Be installed by the following dates per category:
  - Categories 2c and 6: October 1, 2024
  - Categories 4, 4a and 10: September 1, 2025

## Small to Medium Business (SMB): 2024 Promotion for prescriptive projects

To be eligible for 2024 Promotion, SMB projects must:

- Be located within a DAC
- Submit applications between December 5, 2023, through May 31, 2024
- Be installed by October 1, 2024

## **SMB: 2024 Promotion for custom projects**

- To be eligible for the 2024 Promotion, SMB projects must:
  - Submit applications between December 5, 2023, through May 31, 2024
  - Be installed by October 1, 2024
- Incentives for eligible projects will be capped at \$400,000 or 50% of project costs

## **Residential Decommissioning Checklist Revision**

On December 1, 2023, Con Edison updated the Residential Decommissioning Checklist, addressing fuel line removal requirements.

Previous Language

Remove fuel line to the space heating appliance as far back to the source as possible...

Revised Language

Remove fuel line to the space heating appliance to the appliance valve at a minimum.

## **Examples of compliant fuel line removal**

Images showcasing participating contractors properly removing and capping fuel lines to the appliance valve at minimum.





## **Residential QA/QC Update**

In 2024, the program will improve the QAQC inspection process. The current process for prepayment programmatic inspections will remain unaffected in 2024.

#### Pre-payment programmatic inspections:

- Projects that fail pre-payment programmatic inspections will have payment withheld.
- Failures that are not remediated within 30 days will result in project cancelation without payment.

#### QA/QC inspections:

- Currently, QAQC inspections are selected at least 6 weeks after installation.
- Starting in January 2024, the new approach will shorten that timeline resulting in faster delivery results.

All projects must resolve all failed inspections.

## **Decommissioning FAQs**

**Question:** Why is decommissioning a program requirement?

**Answer:** Decommissioning is not a program requirement. There are two incentive offerings for

residential customers installing ASHP: decommissioning and integrated controls both

of which prioritize the operation of the heat pumps for heating.

Question: Do I need to disconnect the exhaust vents?

**Answer:** Yes. Contractors must cut and seal exhaust pipes for the decommissioned heating

system and/or the domestic hot water appliance.

**Question:** Do I need to remove the burner assembly?

**Answer:** Yes.

## **Decommissioning FAQs**

**Question:** Do I need to disconnect distribution systems?

**Answer:** Yes. The best approach depends on the legacy fossil system. Contractors must cut

and seal circulation pipes or seal ductwork as appropriate.



## Introduction of Electrification Load Serving Capacity Maps

- In July 2023, the Public Service Commission mandated that New York electric utilities extend Electric Vehicle Load Serving Capacity Maps to become 'Electrification Load Serving Capacity Maps.'
- Con Edison will release its Electrification Load Serving Capacity maps on January 16, 2024.
- The maps are a high-level summary of system capacity throughout the network.

## Sample Electrification Load Serving Capacity Maps

#### Con Edison's Storage Hosting Capacity Map



- The image on the left is displaying Con Edison's Storage Hosting Map.
  - The same color scheme will be used on the Electrification Load Serving Capacity Map, set to go live on January 16, 2024.
- The Electrification Load Serving Capacity Map will display network capacity beyond the point of service.
