Residential Incentive Changes – Comparison Table

Effective March 1, 2022

Effective March 1, 2022, NYS Clean Heat program incentives for residential projects in Central Hudson, Con Edison, and Orange & Rockland service territories will change to the amounts indicated in the table below. These changes apply only to Categories 1, 2, 2a, and 2b. **All other incentives will remain the same across other categories and utilities.** These changes will also be incorporated and officialized in a subsequent update of the NYS Clean Heat [Program Manual](#).

Con Edison Natural Gas Moratorium Kicker Incentive Changes

Effective March 1, 2022

Effective March 1, 2022, the Con Edison kicker incentive for heat pumps installed within designated gas-constrained areas (e.g., certain areas of Westchester⁴), will be limited to the following Categories at the new rates shown:
