NYS Clean Heat Program Notice

May 9, 2022

Participating Contractors,

Thank you for your participation in the New York State Clean Heat program in Con Edison's service territory. Your efforts have supported many New Yorkers in the move away from fossil-fueled heating, which helps reduce greenhouse gas emissions and achieve our clean energy goals.

Due to the tremendous response from the market, as of April 2022, the Con Edison Clean Heat Program exceeded its 2025 energy savings target and has exhausted all available funding for the program. To keep the program running through today, Con Edison has already transferred millions of dollars of additional funding from other energy efficiency programs. Nevertheless, stronger than expected program participation will soon exhaust this additional funding.

As a result, Con Edison must pause incentives for air-source heat pump projects for space and water heating effective immediately. The Company will continue to accept applications for ground source heat pump projects. These changes do not

affect the NYS Clean Heat program in other utility service territories.

The Company will continue to honor incentives for qualifying projects which have already submitted an application or have already been installed but have not yet completed the application process. The Company will honor incentives on a first come, first served basis for qualifying projects which have a signed customer commitment as of today, until remaining program funding is exhausted.

For projects that have been completely installed as of today, we ask that you complete the incentive application by Friday, May 13 at 5PM. If you cannot complete the application by this time, you must submit a signed proof of customer commitment with supporting documentation by Friday, May 13 at 5PM, and the complete application package by Friday, May 20 at 5PM.

For projects with a customer commitment which have not been installed as of today you must provide proof of commitment and supporting documentation by Friday, May 13 at 5pm.

The customer commitment and supporting documentation must include:

- The signed customer contract or agreement;
- The customer's Con Edison account number;
- The project Manual J, equipment specification sheets; and
- The incentive calculator (if available).

Complete incentive applications for projects with a signed customer commitment

but which are not installed as of today are due by August 1, 2022.

Projects which do not meet the specified submission deadlines will not be eligible for incentives.

In the interests of continuing Con Edison's ASHP program, the Company has filed a request with the New York State Public Service Commission (PSC) for additional program funding (available here in Case 18-M-0084). The Commission is currently accepting comments from the public on this petition. If you would like to comment on this petition, you may do so by emailing your comments to Michelle L. The Company will continue to accept applications for ground source heat pump projects. These changes do not affect the NYS Clean Heat program in other utility service territories.

The Company will continue to review incentive applications for projects which have already submitted complete application packages. To be considered for incentives, we ask that you submit complete incentive application packages, including the signed customer contract, the project load calculation compliant with applicable load calculation standards, equipment specification sheets, and the incentive calculator (statewide clean heat tool) to Willdan by Friday, May 13th at 5PM. Qualifying projects will be honored for incentives on a first come, first served basis until remaining program funding is exhausted. Projects which do not submit completed applications by Friday, May 13th at 5 pm will not be eligible for incentives.

<u>In the</u> interests of continuing Con Edison's ASHP program, the Company has filed a request with the New York State Public Service Commission (PSC) for additional program funding (available <u>here</u> in Case <u>18-M-0084</u>). The Commission is currently accepting comments from the public on this petition. If you would like to comment on this petition, you may do so by emailing your comments to Michelle L. Projects which do not submit a completed package by Friday, May 13th at 5PM will not be eligible for incentives.
